

#### Strategic Energy Advisory & Dialogue Services (SEADS)

#### **Establishing enabling frameworks for energy & climate investments**





- Providing policy advice, developing strategies & regulations for the transformation of energy systems in partner countries
- Building and strengthening partner institutions
- Providing capacity building and technical training to staff members of public institutions
- Thematic research and knowledge sharing

**Results:** 36 policies developed, 13 institutions strengthened, 21 capacity building measures and 13 knowledge products





#### Renewable Energy Cooperation Programme (RECP)

#### Promoting RE market development and investment in Africa





- Policy advisory to enable private sector investment
- Fostering private sector cooperation and joint business development through market information, trade missions, match-making events
- Access-to-finance support for project developers through finance database, project development services
- Innovation and skills development, incl. development of curricula and Africa-EU research events

**Results:** 98 applicants for project advisory, 11 ongoing advisories projected to result in 36 MW (at 50% success rate); 1874 B2B-meetings, 2 Africa-EU research events

#### Rationale and Background

**CEMG sector in Western Africa has not grown at the rate expected,** the lack of clear policy and regulatory instruments is still a main barrier for the large scale deployment of CEMG in WA.

 On this base, ECREEE has request support to EUEI PDF with the objective of improving the policy and regulatory framework for scaling-up mini grids in the region.



The activity falls under the scope of the SE4ALL African Hub activity program coordinated by the AfDB

### ECOWAS: Capacity building & technical assistance on policy and regulation for clean energy mini-grids in West Africa

- Main Objective: Support ministries, regulators and utilities to apply appropriate approaches and methodologies for improving the policy and regulatory framework for CEMG through:
  - Phase 1: **Regional Capacity Building**: Regional training of four days on policy and regulatory framework for the deployment of CEMG (Mar/June 2017)
  - Phase 2: Tailor made technical assistance to improve policy and regulatory framework for CEMG in two ECOWAS member states (July – Nov 2017)
- Partners: ECREEE, ministries, regulators, + some REAs and utilities in ECOWAS region

#### Phase 2: Technical Assistance to two Member states

Choice of the countries in coordination with ECREEE and other donors concerned

#### **Activities**

- Two in-country missions to engage with local authorities
- Support the national government for the improvement of policy and regulatory framework for mini-grids.
- Main outcomes presented to a National workshop

#### Phase 2: Technical Assistance to two Member states -

#### **Deliverables**

- **Development of recommendations**, incl. inter alia specific legal actions required, templates for contracts, and a proposed structure for a tariff regime
- A country action plan including indication on potential partnership and funding opportunities
- Recommendations on how to adequately integrate gender issues and climate impacts policy and regulatory documents.
